### **ADMINISTRATIVE GUIDE FOR THE 11<sup>TH</sup> ANNUAL GENERAL MEETING (“AGM”)**

#### **INDIVIDUAL MEMBERS**

- (1) Members who are unable to attend the 11<sup>th</sup> AGM and who wish to exercise their votes are encouraged to appoint a proxy or the Chairman of the meeting to attend and vote on your behalf at the 11<sup>th</sup> AGM by indicating the voting instructions in the Form of Proxy in accordance with the notes and instructions printed therein.

#### **CORPORATE MEMBERS**

- (1) Corporate members who wish to appoint corporate representatives instead of a proxy to attend and vote at the 11<sup>th</sup> AGM must deposit their original or duly certified certificate of appointment of corporate representative to the Company's Share Registrar, Tricor Investor & Issuing House Services Sdn Bhd (“**Share Registrar**”, “**Tricor**”, or “**TIIH**”), not later than **Monday, 27 July 2026 at 9.00 a.m.**
- (2) Attorneys appointed by power of attorney are required to deposit their power of attorney to the Company's Share Registrar not later than **Monday, 27 July 2026 at 9.00 a.m.** to attend and vote at the 11<sup>th</sup> AGM.
- (3) If a corporate member (through its corporate representative(s) or appointed proxy(ies)) is unable to attend the 11<sup>th</sup> AGM, you may appoint the Chairman of the meeting as your proxy and indicate the voting instructions in the Form of Proxy in accordance with the notes and instructions printed therein.

#### **REGISTRATION ON THE DAY OF 11<sup>TH</sup> AGM**

- (1) Registration will commence at 8:15 a.m. and shall remain open until the conclusion of the 11<sup>th</sup> AGM or such other time as may be determined by Chairman of the meeting. Please read the signage to ascertain the registration area and proceed for registration.
- (2) Please present your original National Registration Identity Card (NRIC) or Passport (for foreign member) to the registration staff for verification. Please ensure your NRIC or Passport is returned to you after registration.
- (3) Upon verification and registration:
  - (a) please sign on the attendance list and an identification wristband will be provided at the registration counter;
  - (b) if you are attending the 11<sup>th</sup> AGM as a member as well as a proxy, you will be registered once and will only be given one identification wristband;
  - (c) no person will be allowed to enter the meeting hall without wearing the identification wristband. There will be no replacement in the event that you lose/misplace the identification wristband; and
  - (d) you may proceed to the meeting venue thereafter.
- (4) Registration must be done in person. Please also note that you will not be allowed to register on behalf of another person even with the original NRIC or Passport of that other person.
- (5) The registration counters will only handle verification of identity, registration and revocation of proxy/proxies. If you have other queries, please proceed to the Help Desk.

## MEETING

- (1) The Meeting will start promptly at 9.00 a.m. Members are reminded to be punctual.

## GENERAL MEETING RECORD OF DEPOSITORS

- (1) For the purpose of determining who shall be entitled to attend the 11<sup>th</sup> AGM, the Company will be requesting Bursa Malaysia Depository Sdn. Bhd. to issue a General Meeting Record of Depositors as at **22 July 2026** and only a depositor whose name appears on such Record of Depositors shall be eligible to attend the 11<sup>th</sup> AGM.

## PROXY

- (1) A member of the Company entitled to attend and vote at the 11<sup>th</sup> AGM is entitled to appoint another person as his proxy to exercise all or any of his rights to attend, participate, speak and vote in his stead. If you are unable to attend the 11<sup>th</sup> AGM in person and wish to appoint a proxy or the Chairman of the meeting to attend and vote on your behalf, please submit your Form of Proxy in accordance with the notes and instructions printed therein.
- (2) You may submit the Form of Proxy electronically via **Vistra Share Registry and IPO (MY) portal ("Vistra SRMY portal")** at <https://srmy.vistra.com> not later than **Monday, 27 July 2026 at 9.00 a.m.** Please do read and follow the procedures to submit Form of Proxy electronically below.
- (3) Otherwise, please ensure that the **Original Form of Proxy** is deposited with the Company's Registered Office of the Company at Suite 5.11 & 5.12, 5th Floor, Menara TJB, No. 9, Jalan Syed Mohd. Mufti, 80888 Ibrahim International Business District, Johor, Malaysia not later than **Monday, 27 July 2026 at 9.00 a.m.**, otherwise the Form of Proxy shall not be treated as valid. No proof of despatch of Form of Proxy will be entertained.
- (4) The Form of Proxy is not required if the member decided to attend the meeting in person.
- (5) If you have submitted your Form of Proxy prior to the meeting and subsequently decided to attend the meeting in person, please proceed to the registration counter to revoke the appointment of your proxy/proxies.

## ELECTRONIC LODGEMENT OF FORM OF PROXY

- (1) The procedures to lodge your Form of Proxy electronically via Vistra SRMY portal website are summarised as below:

Register as a User with Vistra SRMY portal	<ol style="list-style-type: none"><li>1. Visit the Portal at <a href="https://srmy.vistra.com">https://srmy.vistra.com</a>.</li><li>2. Click "Register" and select "Individual Holder" and complete the New User Registration Form.</li><li>3. For guidance, you may refer to the tutorial guide available on the homepage.</li><li>4. Once registration is completed, you will receive an email notification to verify your registered email address.</li><li>5. After verification, your registration will be reviewed and approved within one (1) working day. A confirmation email will be sent once approved.</li><li>6. Once you receive the confirmation, activate your account by creating your password.</li></ol> <p><i>If you are an existing user with Vistra SRMY portal or the TIH Online portal previously, you are not required to register again.</i></p>

Proceed with submission of form of proxy	<ol style="list-style-type: none"> <li>1. After the release of the Notice of Meeting by the Company, login with your email address and password.</li> <li>2. Select the corporate event: <b>CABNET HOLDINGS BERHAD 11TH AGM.</b></li> <li>3. Navigate to the 3 dots at the end of the corporate event and choose <b>SUBMISSION OF PROXY FORM.</b></li> <li>4. Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>5. Indicate the total number of shares assigned to your proxy(s) to vote on your behalf.</li> <li>6. Appoint your proxy(ies) and insert the required details of your proxy(ies) or appoint the Chairman as your proxy.</li> <li>7. Indicate your voting instructions FOR or AGAINST or ABSTAIN.</li> <li>8. Print the proxy form for your record.</li> </ol>
<b>ii. Steps for Corporate or Institutional shareholders</b>	
Register as a User with Vistra SRMY portal	<ol style="list-style-type: none"> <li>1. Visit the portal at <a href="https://srmv.vistra.com">https://srmv.vistra.com</a>.</li> <li>2. Click "Register" and select "Representative of Corporate Holder" and complete the New User Registration Form.</li> <li>3. Complete the registration form with your personal details.</li> <li>4. Once registration is completed, you will receive an email notification to verify your registered email address.</li> <li>5. After verification, your registration will be reviewed and approval within two (2) working days. A confirmation email will be sent once approved.</li> <li>6. Once you receive the confirmation, activate your account by creating your password.</li> </ol> <p><i>(Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact Tricor if you need clarifications on the user registration.)</i></p>

Login to <a href="https://srmv.vistra.com">https://srmv.vistra.com</a> with your email address and password.</li> <li>2. Select the corporate event: <b>CABNET HOLDINGS BERHAD 11TH AGM.</b></li> <li>3. Navigate to the icon "&gt;" at the end of the corporate event.</li> <li>4. Read and agree to the Terms and Conditions and confirm the Declaration.</li> <li>5. Select the corporate holder's name.</li> <li>6. Proceed to download the submission file.</li> <li>7. Prepare the file for the appointment of proxy(ies) by inserting the required data.</li> <li>8. Proceed to upload the duly completed proxy appointment file.</li> <li>9. Select "Confirm" to complete your submission.</li> <li>10. Print the confirmation report of your submission for your record.</li> </ol>
